World War One veteran, legionnaire, attorney, and life enthusiast, Pett took over the 1935 fund campaign, and raised almost triple his \$1,500 quota. He accepted the position of chairman on two conditions: that an office and part-time secretary be established to give the chapter stability (approved) and that women be included on the board of directors (two directors threatened to resign). Pett's board of directors, including two women, put a four-pronged program into place: accident prevention, first aid, life saving and home nursing. Gifts at this level can provide groceries to a disaster-affected family of four for three weeks, can replace eyeglasses or medications lost in a disaster, or can furnish new clothes or a winter coat for young disaster victims. *56 supporters wish to remain anonymous.*
